Historical Sketch

The East Bay Camp was formed in 1930, when its Director Reverend Breen, with the Kiwanis Club, developed Camp Limberlost.* The first session was held in 1931. The original purpose was to promote health and physical fitness for under-privileged children in Bloomington and the vicinity. In 1970, Ellen Abshire, recreation instructor at Illinois State University,

assumed directorship of Limberlost. University involvement became very important, and counselors were predominantly ISU students.

The goal of Camp Limberlost was to provide a flexible, nutritious, and enjoyable outdoor resident experience with emphasis on positive social interactions and development of constructive leisure experiences (Camp Manual 1984). Among other positive attributes, campers developed positive interpersonal relationship skills while learning to work within a group or community, developed varied leisure interests, developed an appreciation for the natural environment, and learned social skills that they could transfer into family and communal living.

East Bay Camp provided the facility for Camp Limberlost until 1984, when it was relocated to Camp Heffernan, approximately 1.5 miles southwest of East Bay. Camp Heffernan, a 140-acre resident camp, was maintained by the W. D. Boyce Boy Scouts Council.

Easter Seal Camp Heffernan provided recreation and outdoor experiences to people with disabilities or special needs. Camp Heffernan was bought by the McLean County Easter Seals and the Bloomington Kiwanis Club from the Boy Scouts in 1989. The site of Camp Heffernan was originally the site of an Illinois State University course titled "Camp Leadership Practicum with Physically Handicapped." For many years ISU was involved in the running of Camp Heffernan.

Camp Heffernan is now known as Timber Pointe Outdoor Center. The camp offers "the premier resource in the state of Illinois providing specialized and inclusive camping and respite programming for individuals with disabilities or special needs and their families in a safe, accessible and beautiful environment." The camp is owned and operated by Easter Seals, Peoria and Bloomington.

*The name Limberlost is probably an allusion to the popular novel by Gene Stratton Porter (*A Girl of Limberlost* 1909) and her other books featuring the natural life of the Limberlost Swamp in northern Indiana.

Scope and Content Note

This collection includes documents, such as committee reports, memos, listings, agendas, minutes and reports, relating to the Easter Seal Camp Heffernan, 1987 to 2000. It includes the formation and history of the East Bay Camp (Camp Limberlost), which was the original facility.
